

**RESOLUTION NO. 032320A**

**AN RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CRANDALL, TEXAS, POSTPONING THE SPECIAL ELECTION TO BE HELD ON THE 2<sup>ND</sup> DAY OF MAY, 2020, FOR THE PURPOSE OF APPROVAL OR REJECTION OF A PROPOSED CITY CHARTER TO THE NOVEMBER 3, 2020 UNIFORM ELECTION DATE; AUTHORIZING EXECUTION OF JOINT ELECTION CONTRACT FOR THE NOVEMBER 3, 2020 ELECTION; PROVIDING A REPEALING CLAUSE; PROVIDING A SEVERABILITY CLAUSE; AND PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, in accordance with the general laws and Constitution of the State of Texas pursuant to City of Crandall Resolution No. 020320RR, a Special Election for the purpose of approval or rejection of a proposed City Charter was ordered to be held on May 2, 2020; and;

**WHEREAS**, pursuant to Section 418.016 of the Texas Government Code, on March 18, 2020, the Governor of the State of Texas signed a proclamation suspending certain provisions of the Texas Election Code and the Texas Water Code to allow all local political subdivisions that are utilizing the May 2, 2020 uniform election date to postpone their elections to the November 3, 2020, uniform election date; and

**WHEREAS**, pursuant to the Governor's proclamation authorizing the City of Crandall to postpone the May 2, 2020 election date, the City Council does by this Resolution exercise its authority to postpone the Special Election ordered for May 2, 2020, for the purpose approval or rejection of a proposed City Charter to November 3, 2020;

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CRANDALL, TEXAS:**

**SECTION 1:** That the Special election previously ordered for May 2, 2020, for the City of Crandall, Texas, for the purpose of approval or rejection of a proposed City Charter is hereby postponed to November 3, 2020.

**SECTION 2:** That all annual applications ballot by mail (ABBM) for voters that are voting by mail due to being over the age of 65 or due to disability will still be valid for the November 3, 2020, election; and that ABBMs for voters who submitted ABBMs based on expected absence from the county shall not be valid for the postponed November 3, 2020 election.

**SECTION 3:** That the voter registration deadline for the November 3, 2020, election is October 5, 2020, the deadline to submit an ABBM is October 23, 2020, and the dates for early voting are October 19, 2020, through October 30, 2020.

**SECTION 4.** That the City Manager is authorized to negotiate and execute an election contract with Kaufman County for the purposes of conducting the postponed election on November 3, 2020.

**SECTION 5.** That should any word, sentence, paragraph, subdivision, clause, phrase or section of this resolution be adjudged or held to be void or unconstitutional, the same shall not affect the validity of the remaining portions of said resolution, which shall remain in full force and effect.


**SECTION 6.** This resolution shall take effect immediately from and after the date of its passage.
